### Job Summary:

Under general supervision, this position is responsible for cleaning and maintaining the appearance of the airport and all common areas within the property. Ensure the best possible experience for the passengers and tenants by maintaining the Airport clean, safe, and operating efficiently. This position operates within and contributes to an environment in compliance with Federal Aviation Administration and all applicable Federal, State, and local building code regulations.

## **Essential Functions:**

- Under direction, ensure that the activities of this position and relevant programs are consistent with the mission, vision, core values, and sponsored initiative of the Akron-Canton Airport Authority.
- Clean all common areas of the facility, this includes but is not limited to; cleaning restrooms, dusting floors and ledges, cleaning carpets and all aspects of floor care, removing trash, general cleaning, etc.
- Discard of collected trash into the appropriate dumpster.
- Check supplies and replace as needed in the restrooms.
- Vacuum and shampoo carpeting as needed. Sweep, mop, deep clean, and buff floors as needed.
- Wash windows as needed.
- Conduct set up, tear down, and sanitation of conference rooms before and after events.
- Use appropriate cleaning equipment safely and follow safety guidelines established by the department. Watch for and report potential safety hazards to department manager.
- Provide customer service to passengers and other guests by responding to their requests as needed.
- Serve as back up help for first responders and airport security staff in emergencies.
- Assist other departments as needed (snow removal, etc.).
- Perform other duties as assigned.
